WHAT IS THIS PRODUCT?

Type: KraneShares Electric Vehicles & Future Mobility Screened UCITS ETF (the "**Fund**") is a sub-fund of KraneShares ICAV, an Irish collective asset-management vehicle ("ICAV") constituted as an umbrella fund with segregated liability between sub-funds with registration number C181441 and authorised by the Central Bank of Ireland as a UCITS pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. Segregated liability between sub-funds means that the assets and liabilities of each sub-fund are segregated by law, so that an investor should have no claims over the assets of a sub-fund in which they do not own shares. The prospectus and periodic reports are prepared for KraneShares ICAV at umbrella level. Shares in the Fund may not be converted into shares in another sub-fund or from one share class in the Fund into another share class within the same sub-fund.

Objectives: The Fund seeks to deliver the performance of companies that are engaged in or expected to derive significant revenues from the production of electric vehicles, their components or in other initiatives that may change the future of mobility ("**Electric Vehicle Companies**").

Investment Policy: The Fund is passively managed and will seek to achieve its objective by tracking the performance of the Bloomberg Electric Vehicles Screened Index (Total Return version (BBEVST)) (the "**Index**") as closely as possible. Under normal circumstances, the Fund invests at least 80% of its net assets in securities or depositary receipts representing securities of the Index. In order to be eligible for the Index a security must (i) be a constituent of the Bloomberg World Equity Aggregate Index (the "**Base Index**"); (ii) belong to the vehicles, electric vehicle components, batteries, hydrogen fuel cells, or raw materials sectors of the Base Index; (iii) have a minimum capitalisation of US\$500 million; and (iv) have a 90-calendar day average daily traded value of US\$5 million. The index also screens out companies that have severe ESG controversies, violate UN Global Compact principles, or derive substantial revenue from restricted sectors like tobacco, fossil fuels, or controversial weapons. Specifically, it removes companies which have been assessed by ESG data provider, Sustainalytics, as having the highest controversy Level or which have breached a principle of the UN Global Compact. The Fund seeks to promote a combination of ESG characteristics, within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation. The Fund seeks to hold all the securities of the Index with the approximate weightings that they have in the Index but may, in certain circumstances, purchase securities that are not included in the Index. The Fund does not intend to use financial derivative instruments. The Fund may also invest up to 10% of its net asset value in other regulated collective investment schemes, including other exchange traded funds.

The Fund may engage in securities lending but does not intend to use repurchase agreements or total return swaps.

The Fund's income will be reinvested, and the Fund does not intend to declare dividends. Save in exceptional circumstances, the Fund will only issue and redeem shares of the Fund ("**Shares**") to certain institutional investors. However, other investors may purchase or sell Shares through brokers on or one more stock exchanges. The Shares trade on these stock exchanges at market prices which may fluctuate throughout the day. Market prices may be greater or less than the daily net asset value of the Fund. Shareholders may redeem Shares on any Business Day (as defined in the Fund supplement) and any other day at the Directors' discretion provided Shareholders are notified in advance. Intended Retail Investors: Typical investors in the Fund are expected to be investors who are seeking exposure to the performance of screened Electric Vehicle Companies and understand the risks associated with an investment in this sector.

Term: The Fund has no maturity date. The Management Company is not entitled to terminate the Fund unilaterally. The Fund may be terminated unilaterally by KraneShares ICAV under certain circumstances as set out in the prospectus for KraneShares ICAV.

WHAT HAPPENS IF WAYSTONE MANAGEMENT COMPANY (IE) LIMITED IS UNABLE TO PAY OUT?

To protect you, the assets of the Fund are held with SEI Investments – Depositary and Custodial Services (Ireland) Limited (the “Depositary”). The Depositary is a separate regulated entity which performs safekeeping duties for the Fund’s assets. In the event of the insolvency of the Management Company, the Fund’s assets in the safekeeping of the Depositary will not be affected. Should the Fund default, the Depositary would preserve the Fund’s assets so that they could be liquidated and the proceeds distributed to the investors. In the worst case, however, you could lose your entire investment. You are not covered by a national compensation scheme.

WHAT ARE THE COSTS?

COSTS OVER TIME
